For all subscriptions to SAAS, clients will be given **one** product key per subscription.

Product key details:



COST

Each product key cost **\$1000**.



VALIDITY

Each product key is valid for a **30-day** period upon activation.




Each product key gives a client access to **STAR LITE, STAR MAX,** and **STAR DATA**.

#### SOFTWARE AS A SERVICE (SAAS) PROGRAM



GLOBALYTICS



Our line of retail products include STAR LITE, STAR MAX and STAR DATA, which is essentially developed from the STAR SYSTEM, made for retail use.

Besides distributing our systems, a portion of the subscription fees will be allocated to the Asset Under Management (AUM) pool for trading purposes.

The profit is then shared with our members under the **SAAS Program** when the AUM obtains a targeted percentile of profit. The percentage and ratio of the perks is distributed and dictated according to the **SAAS Program** that the client is subscribed to.





- All DSR, GPR and GT perks will be paid out according to GT5 entitlements.
- All rewards and GT perks unpaid will be "moved" upwards to the next higher GT Tier along the sponsor genealogy
- For those in the same level as you, there is no compression. Compression only occurs wen your client's subscription tier is lower than yours.





# **GT PERKS COMPRESSED**





All unpaid GT Perks will be compressed upwards to the next higher tier until the maximum GT Perks has been given out.



# Direct Sponsor Reward (DSR)



You subscribed \$1,000,000 into SAAS program (GT5 – 11% DSR) You sponsor A1 \$10,000 (GT1), B1 \$1,000,000 (GT5) and C1 \$100,000 (GT3) Your Direct Sponsor Reward (DSR) will be:

A1 B1 C1 (\$10,000 x 11%) + (\$1,000,000 x 11%) + (\$100,000 x 11%) = \$122,100







GTD

- Converted into GTC when transferred to another user
- Can be used for SAAS subscription<sup>1</sup>
- GT Perks, DSR, GPR, LSR and GTI will be given into this wallet
- Can be withdrawn into USDP wallet
- GTI is given based on the holding of this wallet on 1<sup>st</sup> of each month

#### USDP

- Can be used for SAAS subscription
- Can be transferred up/down the network

GTC

- Can be transferred up/down the network
- Can be used for SAAS subscription<sup>1</sup>

TOKEN

- Can be used for SAAS subscription.
- Can be transferred upward and downward in your own network.

#### \*Notes: <u>Token Included</u>

For GTD and GTC, SAAS Program subscription must fulfil subscription with minimum 50% USDP, and maximum of 20% token with remainder either GTD or GTC.

#### Token Not Included

For GTD and GTC, SAAS Program subscription must fulfil subscription with minimum 50% USDP and 50% GTD or GTC.

#### **Token Only**


For SAAS Program subscription using only tokens, token value cannot exceed 20% of subscription value.

#### Withdrawal Window

• <u>Window 1</u>:

Withdrawals submitted from 1<sup>st</sup> to 10<sup>th</sup> will be processed on 11<sup>th</sup> of the current month

• Window 2:

Withdrawals submitted from 11<sup>th</sup> to 20<sup>th</sup> will be processed on 21<sup>st</sup> of the current month

• <u>Window 3</u>:

Withdrawals submitted from 21<sup>st</sup> to end of the month will be processed on 1<sup>st</sup> of following month

• All withdrawals will incur a 10% administrative fee

• Subjected to 5 – 10 working days approval duration

- GTI is given on the 1<sup>st</sup> of each month based on GTD balance
- GTI calculation only takes into account denominations of 100
